- June 28, 1906** Teamsters Local Union No. 243 Dissolves Due To Merge with Teamsters Local Union No. 272
- January 23, 1909** Teamsters Local Union No. 243 Charters as “Retail Delivery Drivers and Helpers”
Location: Winnipeg, Manitoba, Canada
- March, 1909** Teamsters Local Union No. 243 Dissolves Due To Lack of Membership
- October 1, 1909** Teamsters Local Union No. 243 Charters as “Capital City Brotherhood of Teamsters”
Location: Lansing, Michigan
- August 8, 1911** Teamsters Local Union No. 243 Dissolves Due To Lack of Membership
- June 24, 1913** Teamsters Local Union No. 243 Charters as “General Teamsters”
Location: Woodland, California
- June 24, 1913** Teamsters Local Union No. 243 Dissolves the Same Day Due To Lack of Membership
- April 14, 1916** Teamsters Local Union No. 243 Charters as “General Teamsters”
Location: Lima, Ohio
- January 21, 1919** Teamsters Local Union No. 243 Dissolves Due To Lack of Membership
- February 25, 1920** Teamsters Local Union No. 243 Charters as “Chauffeurs, Teamsters and Helpers”
Location: Cairo, Illinois
- September 29, 1920** Teamsters Local Union No. 243 Dissolves Due To Lack of Membership

September 10, 1921 Teamsters Local Union No. 243 Charters as “Auto Bus Drivers”

January 11, 1926 Teamsters Local Union No. 243 Dissolves Due To Lack of Membership
